



## *Bridal Agreement & Reservation*

## 1. General

Roots Southern Salon requires a non-refundable DEPOSIT to secure your date. This DEPOSIT is required to guarantee your desired date. This DEPOSIT will be applied to the final total of your services. We recommend a trial session for the Bride. We urge that she bring in images of styles she likes and headpieces she may use. Without a trial session, we cannot guarantee the hair will come out exactly the way the Bride wants. During your 45 minute Bridal Trial Run appointment, a complete walk through of the hair style will be done. If you need more time to try several different looks, please let the appointment coordinator know at the time of booking. We also offer a 45 minute makeup consultation to match your skin tone, discuss details for eye makeup, contouring and share ideas for the perfect photo finish look. If you would like to have your hair and makeup done the day of your Bridal portraits or for a scheduled fitting with your seamstress, this is also something we suggest to see the entire look come together. This would need to be a separate appointment from your Trial Run.

## 2. The Day of

Most textures and types of hair will style and hold in an updo much better if hair is washed and prepared the DAY BEFORE. If shampooed immediately prior to styling, it will need to be blown dry and prepped with additional products, costing more money and time and we cannot guarantee end results will last. Please ask all members of the wedding party to use only soft styling sprays in the morning, as hard or stiff sprays make hair extremely difficult to curl and style. We also ask that you or whoever is in charge have all members of the wedding party be on time! If members of the wedding party are not on time, this will make it difficult for the stylist(s) to perform all services on time and effectively. The stylist is only available for the hours agreed upon during the consultation. The stylist will provide all hairpins and styling products. The wedding party can bring, for the stylist to use, any hair ornaments or flowers.

If the Bridal Team is delayed for more than 30 minutes past the originally retained start time due to Bride or Bridal Party's late arrival or is delayed for more than 30 minutes for any other reason, foreseen or unforeseen, an added fee of \$150 beyond contracted price will be charged.

## 3. Travel

For our experts to come to the location you've chosen to get ready for your wedding, we do charge a travel fee. In addition to the cost of styling, a flat fee of \$50.00 per stylist will apply for travel within downtown Savannah, \$100.00 per stylist for travel within 20 miles of Savannah, and \$150.00+ per stylist for travel over 20 miles. One Lead Stylist and an Assist will travel together based on the number of wedding party members and/or services. Additional Leads can be added per request, considering time frame.

## 4. Terms and Conditions

A Credit Card is required to book and hold a wedding party date and time with the DEPOSIT. If the need arises to reschedule your wedding date or time for any reason, we must be notified in writing at least 90 days prior to the event. Moreover, the new date must be established and the event must take place within 120 days of the date that was originally scheduled for the deposit to be applied. If the date is not reestablished and the wedding doesn't occur within this time frame, the event will be deemed as a cancellation and our cancellation policy will take effect.

**Cancellation Policy:** If the request to cancel your reservation with Roots Southern Salon occurs at least 30 days prior to the scheduled event date you will receive a refund for the full amount of your deposit. Conversely, if the cancellation occurs within 30 days of the reserved date, you will not receive a refund for the deposit and the credit card on file will be charged \$250 or 1/2 of the wedding party total, whichever is lesser.

**Refund Policy:** As weather can be somewhat unexpected throughout the year in Savannah, Georgia we willingly provide refunds for a cancellation due to inclement weather such as natural causes (fire, storms, floods, etc.) Based on the unpredictable events we've experienced in 2020 governmental or societal actions such as: global pandemic, state of emergency, mandated quarantine/social distancing guidelines, war, invasion, civil unrest, labor strikes, infrastructure failures, etc. have been added to the list of reasons to refund deposits.

As an available option to cancellation, you may ***postpone the reservation*** with Roots Southern Salon for up to 120 days. The deposit received will be applied to the postponed date if we are notified of your intentions to postpone in a timely manner. Be advised, though, that the particular Bridal Expert you originally contracted for may not be available. Moreover, additional fees may also be incurred.

The Bride assumes all responsibility of payment for the total number of services provided by Roots Southern Salon Bridal Experts. A final number of wedding party members must be reserved and confirmed 30 days prior to the wedding date. If less services are needed on the scheduled event date than confirmed by the Bride on the Reservation and Estimate sheet, the cancelled service(s) will not be refunded, nor will any charges for the cancelled service be credited to any additional charge balance.

\*We do require an additional 18% gratuity charge for wedding parties of 6 or more.

Roots Southern Salon's Bridal Experts will not be responsible for failure to perform duties due to adverse weather conditions, equipment failure, unforeseen events that inhibit or otherwise affect performance, or other circumstances beyond its control. *See more circumstances above per Refund Policy.*

Please agree to hold Roots Southern Salon and our employees harmless from all liabilities, claims, damages and expenses relating to services arising out of this agreement.
